RCI BANK AND SERVICES TOP MANAGEMENT APPOINTMENTS

RCI Bank and Services will change its organizational structure.

As of May 1st, 2018, **François GUIONNET** is appointed VP, Territories and Performance, and joins RCI Banque S.A. Executive Committee. He will act as interim DIAC Managing Director until the appointment of his successor on June 1st, 2018.

Alice ALTEMAIRE is appointed VP, Mobility Services and Innovation effective from May 1st, 2018. She will act as interim VP, Accounting and Performance Control until the appointment of his successor. She remains a member of the Executive Committee.

***François Guionnet**, 56 years old, is a graduate of EDHEC. In 1984, he began his career at Groupe Renault holding various operational positions at DIAC. In 1987, he joined the Commercial Division of Renault in France and then occupied different positions in marketing, network animation, fleet sales. In 2006, he was appointed Regional Direction of Ile de France. In 2008, he became Corporate Sales Director and Managing Director of Renault Parc Entreprise (R.P.E.). In 2013, he joined Renault Network in France as a Director. In January 2016, he is appointed General Manager of DIAC and Nissan Finance.*

*Born in France in 1977, **Alice Altemaire** has a MBA from ESSEC Business School and Board member certificate from IFA Science Po. In 2005, she joined Groupe Renault in the organization division after six years as an organization consultant with PriceWaterhouseCoopers and IBM Consulting, where she worked both in France and in the USA. In 2007, she moved to the Performance Control division of the group where she worked on the G&A optimization. Three years later, she joined RCI Banque as Group controller. She moved to the UK in 2012 as CFO of RCI Financial Services, where she launched RCI's UK deposit bank in 2015. In 2016, she was appointed Vice President, Accounting and Performance Control and became a member of the Executive Committee. Since February 2017, Alice Altemaire chairs the Board of Directors of Karhoo.*

Created and wholly owned by Groupe Renault, RCI Banque S.A. is a French bank specializing in automotive financings and services for the customers and dealership networks of Groupe Renault (Renault, Renault Samsung Motors and Dacia) worldwide, the Nissan Group (Nissan, Infiniti and Datsun) mainly in Europe, Brazil, Argentina and South Korea and through joint ventures in Russia and India, and Mitsubishi Motors in the Netherlands. RCI Bank and Services has been the new commercial identity of RCI Banque S.A. since February 2016. With nearly 3,400 employees in 36 countries, RCI Bank and Services financed over 1.77 million contracts (for new and used vehicles) in 2017 and sold more than 4.4 million services. At end-December 2017, average performing assets stood at €39.6 billion of financings and pre-tax income at €1,077 million. RCI Bank and Services has rolled out a deposits collection business in four countries since 2012. At end-December 2017, net collected deposits totaled €14.9 billion, or 34% of the company's assets.
